8. Conduct a public hearing, discussion and possible action on Ostrander Enterprises request to rezone 0.555 acres from Planned Development District to SF-5 Single Family Residential District and replat the same into two lots.

9. Discussion and possible action on Resolution 20200211-009 of no objection to a housing tax credit application for the Amber Ridge Apartments, LP.

A motion was made by Mayor pro-tem Wright and seconded by Council Member Sillavan, to approve the Resolution.

An amendment was approved on Mayor pro-tem Wright's motion, Council Member Sillavan's second on a 5-0 vote. Council Member Vasut was absent.

The amendment was to revise the heading of the resolution to read:

"RESOLUTION BY THE CITY OF ANGLETON IN SUPPORT OF A HOUSING TAX CREDIT APPLICATION FOR THE AMBER RIDGE APARTMENTS, LP."

The amendment was to revise Section 2 to read:

"SECTION 2. The City of Angleton, acting through its governing body, hereby confirms that it shall provide a financial contribution in the form of reduced building permit fees in the amount of Two Hundred Fifty Dollars (\$250.00) to Amber Ridge Apartments, LP, if the Texas Department of Housing and Community Affairs award 9% Housing Tax Credits to Amber Ridge Apartments, LP."

Upon a motion by Mayor pro-tem Wright and seconded by Council Member Sillavan, Council approved the Resolution 20200211-009, as amended above. The motion passed on a 5-0 vote. Council Member Vasut was absent.

10. Discussion and possible action on Texas Municipal Retirement System (TMRS) benefits for Presiding Judge of Municipal Court of Record.

Upon a motion by Mayor pro-tem Wright and seconded by Council Member Booth, Council approved the TMRS benefits for Presiding Judge of Municipal Court of Record. The motion passed on a 5-0 vote. Council Member Vasut was absent.

11. Discussion and possible action on amending Chapter 4 Animals of the Code of Ordinances of the City of Angleton.

Upon a motion by Mayor pro-tem Wright and seconded by Council Member Sillavan, Council authorized Chief Ausmus to create the Animal Advisory Committee as presented and to add two new members of the community. The motion passed on a 5-0 vote. Council Member Vasut was absent.
