RESOLUTION NO. 20200820-001

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ANGLETON, TEXAS, TO TAKE A RECORD VOTE TO CONSIDER THE PROPOSED PROPERTY TAX RATE FOR 2020 AND FOR CONSIDERATION OF ADOPTION OF THE FISCAL YEAR 2020-2021 BUDGET; SPECIFYING THE PROPOSED PROPERTY TAX RATE; ESTABLISHING DATES FOR PUBLIC HEARINGS ON THE PROPOSED BUDGET AND PROPOSED TAX RATE; AND PROVIDING FOR THE PUBLICATION OF PUBLIC HEARING NOTICES AS PROVIDED BY THE TEXAS TAX CODE & TEXAS LOCAL GOVERNMENT CODE.

WHEREAS, the City of Angleton has received the calculated effective tax rate information as presented by the Brazoria County Tax Assessor/Collector's Office; and

WHEREAS, the proposed tax rate of \$0.675144 exceeds the no-new-revenue effective tax rate of \$0.665144 and does not exceed the voter-approval rollback tax rate of \$0.675966. The Texas Tax Code requires one public hearing in order to entitle the City Council to consider acceptance and adoption of an ordinance levying a proposed tax rate; and

WHEREAS, the Texas Property Tax Code Chapter 26, as heretofore amended, provides the specific procedures in which to consider the proposed tax rate; and

WHEREAS, the Texas Local Government Code, Chapter 102, as amended, provides the specific procedures in which to consider the proposed budget;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ANGLETON, TEXAS:

SECTION 1. The City of Angleton placed a proposal for adoption of the budget for fiscal year 2020-2021, and adoption of the proposed tax rate for 2020 on the agenda for the September 15, 2020 City Council meeting.

SECTION 2. Public Hearing on the proposed tax rate shall be held on September 8, 2020 at 6:00 p.m. in the Angleton City Council Chambers at City Hall located at 120 S. Chenango, Angleton, Texas 77515 to receive public comment, and notice shall be published as set forth in the Texas Tax Code §26.05.

SECTION 3. Public Hearing on the proposed budget shall be held on September 8, 2020 at 6:00 p.m. in the Angleton City Council Chambers at City Hall located at 120 S. Chenango, Angleton, Texas 77515 to receive public comment, and notice shall be published as set forth in the Texas Local Government Code §102.006.

SECTION 4. The City Council of the City of Angleton, Texas met in a public meeting on August 20, 2020, and accepted this resolution with a majority vote as follows:
