THE FOLLOWING REPRESENTS THE ACTIONS TAKEN BY THE ANGLETON SENIOR CITIZEN COMMISSION IN THE ORDER THEY OCCURRED DURING THE MEETING. THE SENIOR CITIZEN COMMISSION OF ANGLETON, TEXAS CONVENED IN A REGULAR MEETING ON MONDAY, SEPTEMBER 21, 2020, AT 11:30 A.M. IN ROOM ONE OF THE ANGLETON RECREATION CENTER, 1601 N VALDERAS, ANGLETON, TEXAS.

- 1. Declaration of a quorum and call to order.
With a quorum present, Pat Aschenbeck, Recreation Specialist, called the Senior Citizen Commission meeting to order at 11:30 A.M.**
- 2. Approve the minutes of the meeting called on Monday, July 6, 2020.
Upon a motion by Senior Commission Member, Judy Shaefer, and second by Senior Commission Member, Sarah Mc Daniel, Angleton Senior Citizen Commission approved the minutes of regular called meeting of July 6, 2020. The motion passed on a 3-0 vote.**
- 3. Discussion on Senior Citizen Commission Strategic Plan.
Pat Aschenbeck, Recreation Specialist, outlined what the strategic plan will consist of. Pat talked about Resolution 2004-R-3A and how the strategic plan will be created. The Commission will identify goals and objectives in regards to housing, transportation, health care, legislation, recreation and quality of life for seniors. To do so, staff will release a survey for seniors in the Angleton community and will utilize the feedback to create through a workshop with the commission a strategic plan. We will work on educating, advising and recommending these items to the Mayor and the City Council. Senior Commission Member Judy Shaefer talked about housing and what options are currently available to seniors in Angleton. Senior Commission Member Sarah Mc Daniel questioned all the different components in the strategic plan. Senior Commission Member Archie Milam questioned the timing of implementing this strategic plan now in regards to its relevance. He also noted that seniors may be on a fixed income.**

4. Discussion on Transportation Division updates.

Recreation Specialist, Pat Aschenbeck discussed the city entering into a contract with Enterprise to lease city vehicles. This contract will include a new recreational bus. Pat informed the members that the bus would be ADA compliant, and could feature tinted windows, an area for wheelchairs and hold 24 passengers or 20 passengers with 2 wheelchairs. The bus would be for senior programming as well as other programs at the rec center, including youth camps. Commission Member Archie Milam talked about the possibility of doing short trips, like Lunch Bunch. He added that restaurants are at 75% capacity. Pat made comment that the Governor had not made any recommendations for seniors to start gathering. Commission Member Sarah Mc Daniel made a comment about the Governor having a town hall meeting and that she would ask about senior gathering trips.

5. Discussion on Recreation Division updates.

Birthday Drive-Thru Update - Recreation Specialist, Pat Aschenbeck discussed gathering quotes for lunches and went with Subway for a boxed sandwich lunch. There was a total of 59 lunches that were passed out with 8 of those being delivered by ActionS to seniors who could not drive. In the goodie bags there was a code for them to get on Zoom for a virtual celebration. There were 11 door prizes given out.

Christmas Drive-Thru Update – Recreation Specialist, Pat Aschenbeck worked on getting quotes for a hot meal for seniors. It was decided to go with Smithhart’s for a hot turkey meal with dressing, mashed potatoes, green beans and a roll. Smithhart’s will supply meals in individual containers as well as in warmer to keep warm. Seniors will also receive a goodie bag and a code for the Zoom virtual celebration. Staff currently has 10 door prizes. Commission Member Judy asked if more door prizes were needed and suggested that she will look into getting more.

Virtual Classes Update – Pat Aschenbeck, Recreation Specialist talked about the Chair Fitness, Cooking Class and the Craft Class and how all three were doing well.

ActionS Update – Pat Aschenbeck, Recreation Specialist discussed that ActionS was still passing out food to any senior in need and that they were still in need of

donations. Also, ActionS has set up a Senior Chat Line to call seniors just to talk, or seniors to call if they feel the need to talk to someone.

6. Items for the next Senior Citizen Commission meeting.
Pat set the next meeting for October 19th, during which time the commission will conduct the strategic planning workshop. Commission Member Judy would like to discuss the Senior Christmas Drive-Thru and receive an update during the next meeting.
